ARTICLES OF INCORPORATION
OF
GREELEY TERRACE HOMEOWNERS ASSOCIATION

I

The name of this corporation shall be GREELEY TERRACE HOMEOWNERS ASSOCIATION.

II

A. This corporation is a nonprofit Mutual Benefit Corporation organized under the Nonprofit Mutual Benefit Corporation Law. The purpose of this corporation is to engage in any lawful act or activity, other than credit union business, for which a corporation may be organized under such law.

B. The specific purpose of this corporation is to provide for the maintenance, preservation, protection, management and architectural control of the mixed use condominium project commonly known as GREELEY TERRACE, located in the County of Los Angeles, State of California (Tract 63597), and to promote the health, safety and welfare of the residents within the above-described property.

III

This corporation is an association formed to manage a common interest development under the Davis-Sterling Common Interest Development Act.

IV

Notwithstanding any other provision of these Articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation. This corporation does not contemplate pecuniary gain or profit to the Members hereof and is organized solely for nonprofit purposes.

V

The Corporation has no managing agent.

VI

The Corporation has no business office.

VII

No substantial part of the activities of this corporation shall consist of carrying on

propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

VIII

The personal liability of the directors of this corporation for debts, liabilities or obligations relating to this corporation shall be eliminated to the fullest extent permissible under California law.

IX

The authorized number and qualifications of members of the Corporation, the different classes of membership, if any, the property, voting and other rights and privileges of members and their liability for dues and assessments and the method of collection thereof, shall be as set forth in the Bylaws.

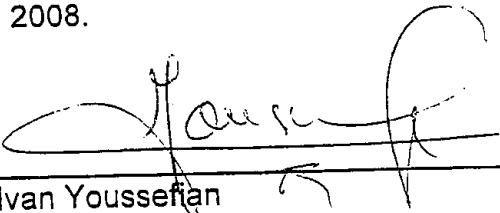
